This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

A. Applicable Emissions Limitations and/or Control Requirements

2. Additional Terms and Conditions

- (a) The Best Available Technology (BAT) requirements under OAC rule 3745-31-05(A)(3) do not apply to the particulate emissions from this air contaminant source since the calculated annual emission rate for particulate emissions is less than ten tons per year taking into account the federally enforceable rule limit of 0.20 pound particulate per 100 pounds of liquid, semisolid or solid refuse and salvageable material charged to the incinerator under OAC rule 3745-17-09(C).
The Best Available Technology (BAT) requirements under OAC rule 3745-31-05(A)(3) do not apply to the uncontrolled OC, NOx, CO and SO2 emissions from this air contaminant source since the potential to emit for OC, NOx, CO and SO2 is less than ten tons per year.
This emissions unit is exempt from the requirements of OAC rule 3745-18-06 because natural gas is the only fuel burned.

B. Operational Restrictions

1. The permittee shall not charge this emissions unit with an "infectious agent" as defined in OAC rule 3745-75-01(B)(19).

E. Testing Requirements

1. Compliance with the emission limitations specified in section A.1 of these terms and conditions shall be determined in accordance with the following methods:
Emission Limitation:

Particulate emissions shall not exceed 0.20 pound per 100 pounds of liquid, semisolid or solid refuse and salvageable material charged to the incinerator.

Applicable Compliance Method:

If required, compliance with this mass emission limitation shall be based on stack testing per OAC rule 3745-17-03(B)(8), (USEPA Method 1-5, 40 CFR 60, Appendix A).

Emission Limitation:

Visible particulate emissions from any stack shall not exceed 20% opacity as a 6-minute average, except as provided by the rule.

Applicable Compliance Method:

Compliance with this emission limitation shall be determined by USEPA Method 9 (40 CFR Part 60, Appendix A).

F. **Miscellaneous Requirements**

1. A copy of these terms and conditions shall be visibly posted near the incinerator.
2. This incinerator shall be operated only by personnel adequately trained.
