GENERAL PERMIT CONDITIONS

TERMINATION OF PERMIT TO INSTALL

Substantial construction for installation must take place within 18 months of the effective date of this permit. This deadline may be extended by up to 12 months if application is made to the Director within a reasonable time before the termination date and the party shows good cause for any such extension.

NOTICE OF INSPECTION

The Director of the Ohio Environmental Protection Agency, or his authorized representatives, may enter upon the premises of the above-named applicant during construction and operation at any reasonable time for the purpose of making inspections, conducting tests, or to examine records or reports pertaining to the construction, modification or installation of the source(s) of environmental pollutants identified within this permit.

CONSTRUCTION OF NEW SOURCES

The proposed source(s) shall be constructed in strict accordance with the plans and application submitted for this permit to the Director of the Ohio Environmental Protection Agency. There may be no deviation from the approved plans without the express, written approval of the Agency. Any deviations from the approved plans or the above conditions may lead to such sanctions and penalties as provided under Ohio law. Approval of these plans does not constitute an assurance that the proposed facilities will operate in compliance with all Ohio laws and regulations. Additional facilities shall be installed upon orders of the Ohio Environmental Protection Agency if the proposed sources are inadequate or cannot meet applicable standards.

If the construction of the proposed source(s) has already begun or has been completed prior to the date the Director of the Environmental Protection Agency approves the permit application and plans, the approval does not constitute expressed or implied assurance that the proposed facility has been constructed in accordance with the approved plans. The action of beginning and/or completing construction prior to obtaining the Director's approval constitutes a violation of Ohio Administrative Code (OAC) Rule 3745-31-02. Furthermore, issuance of the Permit to Install does not constitute an assurance that the proposed source will operate in compliance with all Ohio laws and regulations.

Approval of the plans in any case is not to be construed as an approval of the facility as constructed and/or completed. PUBLIC DISCLOSURE

The facility is hereby notified that this permit, and all agency records concerning the operation of this permitted source, are subject to public disclosure in accordance with OAC Rule 3745-49-03.

APPLICABILITY

This Permit to Install is applicable only to the contaminant sources identified. Separate application must be made to the Director for the installation or modification of any other contaminant sources.

2. The emissions limit based on OAC rule 3745-21-09(U) is less stringent than the limit established pursuant to OAC rule 3745-31-05.

B. Monitoring and/or Record Keeping Requirements

1. The permittee shall collect and record the following information each day for the paint spray booth (K001):
 - a. the name and identification number of each coating employed;
 - b. the volume, in gallons, of each coating employed; and,
 - c. the total volume, in gallons, of all of the coatings employed.
2. The permittee shall collect and record the following information for the purpose of determining annual VOC emissions from K001:
 - a. the name and identification of each cleanup material employed;
 - b. the number of gallons of each cleanup material employed;
 - c. the VOC content of each cleanup material, in pounds per gallon;
 - d. the VOC content of each coating, as applied, in pounds per gallon; and,
 - e. the total VOC emissions from all coatings and cleanup materials employed, in pounds or tons.

C. Reporting Requirements

1. The permittee shall notify the Director (Ohio EPA, Northeast District Office) in writing of any daily record showing that the coating line employs more than the applicable maximum daily coating usage limit. The notification shall include a copy of such record and shall be sent to the Director Ohio EPA, Northeast District Office) within 45 days.

2. The permittee shall submit annual reports which specify the total V C emissions from these emissions units for the previous calendar year. These reports shall be submitted by January 31 of each year.

D. Testing Requirements

1. **Emissions Limit:** 8 gallons per day coating.
Applicable Compliance Method: Compliance shall be based upon the record keeping specified in these Additional Special Terms and Conditions, section B.1.
2. **Emission Limit:** 10.4 tons per year of VOC.
Applicable Compliance Method: Compliance shall be based upon the recordkeeping specified in these Additional Special Terms and Conditions, section B.2.
3. **Emission Limit:** Visible emissions shall not exceed 5% opacity, as a six minute average, during any sixty-minute observation period.
Applicable Compliance Method: Compliance shall be determine by using Method 9, as specified in 40 CFR 60, Appendix A.
4. **Emission Limit:** 0.551 pounds of TSP per hour, 2.41 TPY of TSP.
Applicable Compliance Method: Compliance with this emissions limit shall be determined based on OAC rule 3745-17-03 (B)(10)(b).
