

ABOUT THE TRAINING

The Ohio Rural Water Association (ORWA) has partnered with the Ohio Environmental Protection Agency (Ohio EPA) and Ohio Manufactured Homes Association (OMHA) to provide **FREE** training to small public water systems (populations of 3300 and under). These classroom trainings are offered free of charge along with an optional on site lunch and the ability to obtain 6 O&M contact hours.
